Proviso 81.3 (LLR: POLA - 10%, Other Funds) directed LLR to transfer an amount equal to 10% of the expenditures in Program II.F. Professional and Occupational Licensing and all revenues above expenditures for the Contractor's Licensing Board. In FY14, the amount remitted to the general fund was \$2,980,344.17.
